1. Introduction and Regulatory Framework

Absolute Reliant Solutions LLC is a business management consulting and professional services firm providing business management consulting, tax preparation, bookkeeping, payroll support, business formation services, and related administrative and financial management support services. All data practices conform to the Texas Identity Theft Enforcement and Protection Act (Texas Bus. & Com. Code § 521), federal Gramm-Leach-Bliley Act (GLBA) financial privacy safeguards, and Internal Revenue Code (IRC) § 7216 statutory disclosure restrictions.

2. Information We Collect

To execute professional services and client onboarding, we collect the following information:

- **Identification and Contact Information:** Full name, business trade name, mailing address, email address, telephone numbers, and mobile numbers.
- **Tax and Financial Records:** Protected numbers (SSNs, ITINs, EINs), income statements, W-2s, 1099s, bank details, bookkeeping ledgers, and payroll archives.
- **Business Formation Data:** Ownership files, registered agent structures, and details required for Corporate Transparency Act (CTA) Beneficial Ownership Information (BOI) submissions.

3. Purpose of Processing and IRC § 7216 Restrictions

Data is processed strictly to execute professional service contracts, maintain files, and comply with tax authorities.

IRC § 7216 Stricture: Pursuant to Internal Revenue Code Section 7216, any tax return info collected or generated during our tax preparation services will never be used or disclosed for any objective other than tax preparation support, unless a standalone, separate written consent authorization is executed by the client.

4. Strict SMS/MMS Anti-Sharing Privacy Standards

We do not sell, rent, lease, or share personal information with third parties for their own marketing purposes.

In particular, mobile phone numbers, SMS/MMS opt-in information, consent records, and related messaging information will not be sold, rented, or shared with third parties or affiliates for their own marketing or promotional purposes. Your SMS/MMS opt-in information will be used only as described in this Policy and for purposes reasonably necessary to provide the communications and services you have requested.

5. Core SMS Terms & Conditions

By providing your mobile telephone number and affirmatively opting into text messaging updates with Absolute Reliant Solutions LLC, you agree to the following programmatic terms:

- **Message Description & Purpose:** Absolute Reliant Solutions LLC utilizes text messaging to deliver critical, non-marketing operational updates. These messages include transactional appointment reminders, time-sensitive tax documentation requests, payroll processing deadlines, bookkeeping clarification alerts, and administrative status updates relating directly to the professional services you have requested.
- **Message Frequency:** Message frequency varies depending on individual client activity, document collection requirements, and ongoing project engagement volume.
- **STOP Opt-Out Instructions:** You can cancel the SMS service at any time. Just text **STOP** to our business number in response to any message. After you send the SMS message **STOP** to us, we will send you an SMS message to confirm that you have been unsubscribed. After this, you will no longer receive SMS messages from us.

6. Authorized Disclosures and Service Providers

We disclose personal data to limited third-party sub-processors essential to operations (e.g., secure tax engines, secure cloud file systems, and IT administrators). These providers are contractually authorized to process information solely to execute tasks on our behalf and are barred from using it for independent marketing.

Legal Mandates & Business Transfers: Information may be disclosed to comply with valid legal subpoenas, court orders, IRS audits, or as part of a corporate restructure, merger, or asset sale.

7. Data Security and Safeguards

In alignment with GLBA Standards and Texas Bus. & Com. Code § 521, we deploy administrative, technical, and physical security measures. Files are encrypted at rest and in transit. Client data access is strictly gated via multi-factor authentication (MFA).

8. Structured Data Retention and Secure Destruction

Tax and financial records are retained for a minimum of **seven (7) years** to satisfy regulatory frameworks. Following this lifecycle, physical documentation is completely shredded and digital volumes undergo permanent cryptographic sanitization.
